Parish families and friends are welcome to participate in the St. Gilbert Ski Club. All participants are required to complete permission slips, medical release, and ski rental liability forms. Children ages 7 to 18 must purchase the \$18.00 student club ID card once per season. This card includes a free ski or snowboard lesson. Lift tickets are \$19 and ski/snowboard rentals are \$18. See summary of benefits for more information on the Student Club ID card.

The St. Gilbert Ski Club table is located in the back of the Alpine Valley main floor Fairview cafeteria from 1:15 PM until 2:30 PM to purchase lift tickets, rental forms and ski/snowboard cards. Cash or checks only are accepted. Checks should be made out to St. Gilbert Ski Club.

Skiing is from 3 PM to 10 PM. Student ski/snowboard evaluations begin promptly at 3:00 PM. Please allow enough time to pick up lift tickets, rental equipment and obtain the student ski evaluation. We recommend a minimum of 45 minutes. All students must be evaluated prior to hitting the slopes.

Student Club ID / Discount Card

All students ages 7 to 18 must purchase a Student Club ID / Discount Card at \$18.00 each. Included with the Student Club ID / Discount Card is a coupon for either a ski or snowboard lesson. The Student Club ID / Discount Card must be with the student when skiing. Ski / Snowboard lessons begin promptly at 3:00 PM for 50 minutes. Additional lessons can be purchased at the Ski School Desk for \$18.00 per ski or snowboard lesson. Student Club ID card members receive lift tickets for \$19.00 and ski or snow board rental for \$18.00 on our scheduled ski nights. Parents, family, and friends are encouraged to join in the fun with the same discounted rates only on the St. Gilbert's scheduled ski nights.

The Student Club ID / Discount Card allow the student to receive the same low prices for lift tickets and rentals, as many times as they wish Sunday through Friday evenings from 3:00 PM to close. Remember, the Student Club ID / Discount Card must be presented at the lift ticket room to receive the discount. Club members also receive a one-time discount of 10% off regular prices for helmets in the ski shop.

RENTAL AGREEMENT

I further recognize and acknowledge that the -risks inherent in the sport of skiing can be greatly reduced by taking lessons, abiding by the Skier Responsibility Code-(known as Your Responsibility Code), and using common sense.

I FREELY ASSUME ALL RISKS OF INJURY ASSOCIATED WITH SKIING

I understand that the boot/binding system which I have rented is designed to reduce the risk of certain injuries to the lower leg. It will not release at all times, nor under all circumstances where a release may prevent an injury, not is it possible to predict every situation in which it will release. I understand the boot/binding system therefore does not guarantee any safety.

I further agree and understand that although the boot/binding system that I have rented may reduce the risk of certain injuries to the bones of my lower leg, it will not at all reduce the risk of injury to my knees or other parts of my body in the event of a backwards fall.

I accept for use in its AS IS condition the equipment listed on this form and accept full responsibility for its care while in my possession. I will be responsible for the replacement, at full retail value of any equipment rented from Alpine Valley Resort, Inc. under this agreement, which is not returned. I agree to reimburse Alpine Valley Resort, Inc. for any loss or damage of any kind to the rental equipment Other than reasonable wear and tear. I agree to return all rented equipment on the agreed date, in clean condition, to avoid additional charges.

I have made no misrepresentations to Alpine Valley Resort, Inc. in regard to my height, weight, age, or skiing ability. All instructions on the use of my rental equipment were made clear to me and I understand the function of my equipment.
